

Gift of US Dollars to the Community Foundation of Nova Scotia

Charitable Registration Number: 87038 9368 RR0001

Background:

- Community Foundations of Canada (CFC) facilitates gifts from U.S. donors into Canada on behalf of the Community Foundation of Nova Scotia.
- CFC provides American donors with the opportunity to donate through Friends of Community Foundations of Canada (FOFCF), which is a designated 501c3 organization based in Arizona. Its Tax ID (EIN) is 61-1958124.
- Donations from American individuals, charities, and corporations to FOFCF will be eligible for tax receipts that can be used for American tax filings with the IRS.
- CFNS receives the donation and designates it to the Fund indicated by the donor at the time of the gift.

Step 1: Fill out the FOFC Gift Letter in full (contact CFNS for the form).

- The gift intent – **Name of the Fund** at Community Foundation of Nova Scotia.
- Payment of gift – Amount and payment type.

Step 2: Email the form to donate@cfns.ca. AND Andrea Matusova, Director of Finance Community Foundations of Canada amatusova@communityfoundations.ca to inform us of the incoming donation.

Step 3: Donor issues a cheque on their US bank account to **Friends of Community Foundations of Canada** and mail it as well as the gift agreement noted, to the CFC Canadian office in Ottawa:

Payment via wire transfer is also accepted. Contact Andrea to arrange a wire transfer.

Timeline: Generally, it can take between 6-8 weeks for the entire gift process to be completed.

Step 4: CFNS receives the funds from CFC and deposits them into the designated Fund at CFNS.
